A member of the public expressed his support of the efforts of the Parish Council in raising funds to assist maintain a local bus service. It was suggested that other local Parish Councils might also assist with funding where services crossed their area.

It was mentioned that a 'bus bill' is to be presented to the House of Commons in the future which might help local bus services across the country.
