Cllr Alsop declared a personal and prejudicial interest in relation to planning application 2015/0179 since he lived in the immediate vicinity of the property concerned. He left the room and did not take part in the debate or voting on this matter.

The meeting was not adjourned since no members of the public were present – a member of the Council did however mention that F/P 10 was to be repaired now that funding had been obtained.

It was also noted that no response had been received in respect of this Council's request for horse rider caution signs – LCC had now removed all public realm managers – the Chairman in his capacity as a LCC Cllr agreed to follow this up.

To consider whether this Council will make a contribution towards the installation of a street light in Drumacre Lane North near to the entrance to the Brickcroft the total cost of which is £1300.

It was resolved that this Council would be prepared to fund up to 50% of the cost of the installation of street lighting provided that the remaining 50% could be found from other sources and subject to this Council agreeing on the design and type.
